John Gould (University of Western Australia) has won the FIRN Best Paper Award at the FIRN Doctoral Tutorial for his paper *The Joint Hedging and Leverage Decision*. The panel of experts was impressed with the very high quality of the papers presented by 10 affiliated FIRN PhD students. John's paper was selected as the top one of a very strong field. Congratulations to John and to all the other presenters for their excellent work.

In 2007, FIRN received the highest number ever of submissions to the Doctoral Tutorial. Due to the limited number of places available, many very promising candidates could not be invited to present their paper and we would like to encourage unsuccessful candidates to submit their project for presentation at the FIRN Doctoral Tutorial 2008 in due course.


UNSW / FIRN Workshop for PhD students
